Signature Update: (F.S. 98.077)

- It is very important that you keep a current updated signature on file with this office. You may update your voter registration signature at any time by submitting a written request to the Supervisor of Elections. You can use a voter registration form available online at www.bayvotes.org or you can pick up a voter registration form at any public service agency, library or city hall. You may also obtain one by calling the Bay County Supervisor of Elections Office at 784-6100, or by coming to our office at 830 W. 11th Street, Panama City, FL.
- If your signature has changed over the years, update it now! All absentee signatures are compared to your signature on file. If it does not match, the canvassing board under legal requirements must and will reject your absentee ballot.
