## POLICY ON ELECTRONIC FILING

r office is requiring the electronic filing of campaign treasurer reports at no cost to you in order to make npaign contributions and expenditures readily available to the public. Campaign Finance Reports, for all al races, will be displayed on our web page and will be loaded on a computer in our office so they can be wed and printed.

OUR USER NAME FOR ELECTRONIC FILING IS YOUR LAST NAME IN LOWER CASE, YOU WILL SO BE REQUIRED TO DESIGNATE A PASSWORD FOR YOUR INITIAL SOFTWARE SET-UP.

#### POLICY ON LATE REPORTS

a courtesy reminder, our office will e-mail candidates and treasurers at least 4 days prior to a reporting due if you provide us with your e-mail address. We will wait two (2) days after the deadline to see if the report ives by mail, postmarked on or before the report deadline date. On the second day, we will mail a certified ter to the candidate informing him or her that the report has not been received and is subject to a fine each y late, according to Florida Statute 106.07. If our office does not receive a response to this letter, the matter ll be forwarded to the Florida Elections Commission, and could be determined to be a willful violation. If plicable, the fine must be paid within twenty (20) days after the receipt of the notice of payment due. The orida Elections Commission will be notified if fines have not been remitted in a timely manner, and they will resue the fine.

#### POLICY ON JUSTIFYING LATE REPORTS

ports must be filed timely. There are no justifiable reasons for filing late reports unless otherwise determined the Florida Elections Commission. Power outages, malfunction of the computer and/or computer program lure are not valid and acceptable reasons for not filing timely. Regardless, you are required to submit, as ficial record, a signed hard copy of your reports.

#### POLICY ON AMENDING REPORTS

hen it is determined that a report needs to be amended, our office will initially contact the candidate by ephone and request that the report be amended within three (3) days. If no response is received, a formal ter will be sent requesting an amended report that must be completed and filed with our office within three days of receipt of notification. If the amended report is not received within this time frame, the matter will referred to the Florida Elections Commission and could be determined to be a willful violation.

### POLICY ON REVIEW OF REPORTS / POLICY ON AMENDING REPORTS

or office checks the following: Summary page for accuracy and signatures, complete names and addresses for contribution and expenditure, occupation of contributor when required, purpose of expenditure listed, and intributions that exceed the lawful amount. This does not relieve you of the responsibility for the correctness discuracy of your reports. I have read and understand the policy above
