POLICY ON ELECTRONIC FILING

ur office is requiring the electronic filing of campaign treasurer reports at no cost to you in order to-make mpaign contributions and expenditures readily available to the public. Campaign Finance Reports, for all cal races, will be displayed on our web page and will be loaded on a computer in our office so they can be ewed and printed.

OUR USER NAME FOR ELECTRONIC FILING IS YOUR LAST NAME IN LOWER CASE. YOU WILL LSO BE REQUIRED TO DESIGNATE A PASSWORD FOR YOUR INITIAL SOFTWARE SET-UP.

POLICY ON LATE REPORTS

s a courtesy reminder, our office will e-mail candidates and treasurers at least 4 days prior to a reporting due te if you provide us with your e-mail address. We will wait two (2) days after the deadline to see if the report rives by mail, postmarked on or before the report deadline date. On the second day, we will mail a certified tter to the candidate informing him or her that the report has not been received and is subject to a fine each ay late, according to Florida Statute 106.07. If our office does not receive a response to this letter, the matter ill be forwarded to the Florida Elections Commission, and could be determined to be a willful violation. If pplicable, the fine must be paid within twenty (20) days after the receipt of the notice of payment due. The lorida Elections Commission will be notified if fines have not been remitted in a timely manner, and they will Irsue the fine.

POLICY ON JUSTIFYING LATE REPORTS

eports must be filed timely. There are no justifiable reasons for filing late reports unless otherwise determined y the Florida Elections Commission. Power outages, malfunction of the computer and/or computer program ilure are not valid and acceptable reasons for not filing timely. Regardless, you are required to submit, as ficial record, a signed hard copy of your reports.

POLICY ON AMENDING REPORTS

Then it is determined that a report needs to be amended, our office will initially contact the candidate by lephone and request that the report be amended within three (3) days. If no response is received, a formal tter will be sent requesting an amended report that must be completed and filed with our office within three) days of receipt of notification. If the amended report is not received within this time frame, the matter will referred to the Florida Elections Commission and could be determined to be a willful violation.

POLICY ON REVIEW OF REPORTS / POLICY ON AMENDING REPORTS

ur office checks the following: Summary page for accuracy and signatures, complete names and addresses for ich contribution and expenditure, occupation of contributor when required, purpose of expenditure listed, and intributions that exceed the lawful amount. This does not relieve you of the responsibility for the correctness 1d accuracy of your reports. I have read and understand the policy above
